Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

The overall percentage grade (a real number between 0 and 100) will be rounded up, to the nearest integer, before the conversion table is used to obtain a letter grade.

This course will have a Registrar Scheduled Final exam that will be delivered in-person and on campus. The final exam for this course will be designed to be completed within 2 hours.

In order to obtain a grade above "D+", students must obtain a weighted-average grade of "C-" (58%) or better for the test component for this course - that is, for the term tests and the final examination.
